2. Independent Study or Research SUMMARY proposal: Independent study or research should be used for individual pursuit of topics within or beyond a student's major field of study which transcend the regularly available curriculum. When planning for independent study or research, the student and his or her advisor should strive to maintain a balance between this mode of study and other elective courses.

The Dean's office will process your application and request your course registration through Records & Registration. We suggest that you check PAWS to ensure that you have been registered. If you have not been registered within 2 weeks of receiving approval, contact Records & Registration. The last day to be registered for Independent Study/Research is the last day of the drop/add period (usually the end of the first week of classes in the semester in which you will be enrolled in the course).

4. Research requirements: Together with the faculty supervisor, student should outline course deliverables and assessments. This should include frequency and duration of meetings with the faculty sponsor, and dates for completion of project milestones where applicable. The methods by which the student's work will be evaluated must be clearly stated in the proposal. Some appropriate forms of evaluation include a paper, a poster, and/or a presentation. To determine the number of credits, the guideline of a minimum of 12 hours of effort per week per course unit shall apply.

The faculty supervisor must be a full-time Sociology or Anthropology faculty member who agrees to oversee this research experience.
